# 2020-2021 Snapshot of progress on Community Strategic Plan

#### Theme I: Liveable

'...a liveable community is an inclusive place which provides for everyone – a place where we can be involved, healthy and active. A place we are proud of. A place where others want to be. A great place to live.'

#### Parks & Gardens

The Parks and Gardens team continue to provide an invaluable service to the community and the pristine condition of the Shire's sporting and recreation grounds is a credit to the hard work and dedication from the team. The Council receives much feedback from both tourists and community members about the impressive state of our Shire.

In August 2020, the official opening of the Junee Dog Agility Park; a project completed in conjunction with the GEO Group. The new amenities building at Laurie Daley Oval was also officially opened, which was fittingly dedicated to the late William 'Bill' Deacon.





The Junee Skate Park underwent a major facelift in the latter part of 2020 thanks to funding received from the NSW Government's *Stronger Country Communities Round Three*. The enhancement work aimed to provide a safer, more modern and aesthetically pleasing facility not only for the youth but for the Junee Shire community in its entirety.



Also unveiled in late 2020 was the new Junee Regional Adventure Park, which received funding through the NSW Governments, My Community Project. The project promotes physical activity for young children living in and visiting the town, at a facility that is of a high standard. It provides an ideal venue for families to interact. The inclusion of an Ngumba-Dal Learning Community and sensory play area with a special purpose swing for those with disabilities completes the project.





# **Community Programs**

Seventeen events and activities were scheduled during the Spring 2020 school holidays at both the Junee Recreation Centre and Junee Library. Over the Summer 2020/21 school holidays the Junee Recreation Centre ran a smaller program of fun fitness and pool games.

Planning commenced on the 2021 Australia Day program, which for the first time is to be held at the Athenium Theatre. A National Day of Thanks is to be incorporated into the program which acknowledges those that assisted the community and surrounds during the 2020 bushfires and COVID-19.

Unfortunately, due to COVID-19 many community events did not take place in 2020, these included Rhythm n Rail, Junee Show, Illabo Show and Christmas on Broadway. Council will continue to work with these committees to ensure our support is the most effective it can be.

# **Junee Junction Recreation & Aquatic Centre (JJRAC)**

JJRAC ran a number of school holiday programs which involved physical activities. An 'Active Kids' program was developed, which included an eight week "Try Sports" programs implemented in conjunction with local sporting organisations. The program was completed by 42 attendees.



Stadium attendance rates have remained consistent even though COVID-19 restrictions restricted some uses. The introduction of the Active Kids "*Try Sports*" program helped boost use at the stadium.

Casual attendance and membership rates across all areas tracked marginally lower due to COVID-19 restrictions.

20% of JJRAC classes are specifically targeted to support senior citizens and a further 10% are suitable for seniors with a higher level of ability.

JJRAC are currently running classes each week suitable for participation for people who have a disability. A wheelchair for access to the program pool has also been added.

Works commenced on the renovations of the main administration office to accommodate Synergy Health Works who will offer physiotherapy services at JJRAC commencing February 2021.

#### **Junee Library**

The Junee Library held a variety of school holiday activities, subject to COVID-19 restrictions. Although these restrictions did hinder many events, a total of 22 activities were completed during the reporting period.

Attendance rates were down by the enforced closure and restrictions resulting from COVID-19.

#### The Athenium Theatre

Major refurbishment works at the Athenium were completed in November 2020. The Theatre now has a fully functioning commercial kitchen, new storage area, outdoor function space, air conditioning and heating. An all-accessible public toilet has also been included in the new additions. This facility is open to the public from 7.00am to 6.00pm daily.





The Theatre was closed during the construction period and re-opened to the public on 28 November 2020 with a sell out concert by Fanny Lumsden.

# **Villages**

Council continues to showcase our surrounding villages, selecting a different village each quarter to feature in the Community Newsletter. Bethungra featured heavily in the Spring 2020 newsletter with articles on improvements to Memorial Park and the new Bethungra Spiral platform and Bethungra Dam walkway. In the Summer 2020/21 edition our villages were featured in a number of articles relating to improvements and village pride.

#### Youth

The Junee Youth Council in the latter part of 2020 jumped back into business having spent much of 2020 with minimal face to face meetings due to COVID-19. Communication however remained ongoing via email and social media during this time.

Focusing on lifting their profile and assisting the community, the Youth Council team volunteered their time assisting at the Athenium Theatre gala re-opening event featuring Fanny Lumsden and earlier in the day at the Official Opening of the newly upgraded Junee Skate Park.





As part of the official Skate Park opening and in conjunction with Youth Week, learn to Skate workshops were conducted by TOTEM Skateboarding. Even with 38-degree heat participation levels were fantastic and feedback was well received.

# **Independent Living**

The development of the Junee Lifestyle Village continues. This private development now has units that can be purchased off the plan.

# **Theme 2: Prosperous**

'...a prosperous community provides choices and opportunities for investment, employment and learning. We focus on the things that will attract visitors and new residents which in turn generate wealth and vibrancy. We do more with what we have. We are mindful of change and quick to adapt...'

#### **Strong Partnerships**

Council continues it's strong relationships with Junee Business and Trades (JBT) and the Junee Sports Committee with a focus of supporting and growing our local businesses, trades and sporting organisations.

In 2020 the most relevant emerging issue was dealing with altered work practice as a result of the COVID-19 pandemic. Council and businesses worked together to ensure relevant information and support was distributed across the business community.

# **Capital Works Program**

Delivery of the road network capital and renewal program continues to be enhanced. Major areas of work for the first part of 2020/21 were: Canola Way (widened one section), construction of the Junee Sewage Treatment Plant access road, sealed Illabo streets, resealed various rural roads, Brabins Road widening and Bethungra village street preparation.



#### **Inland Rail Project**

The ARTC continues to keep the community and Council informed on the development of the Melbourne to Brisbane Inland Railway project.

The new Illabo to Stockinbingal rail line design is almost complete and the construction phase will provide further opportunity for local and other rail related industry advocacy.

# **Development Control**

All applications received have been assessed in accordance with legislation and planning guidelines, resulting in good development being undertaken.

Builders and tradespeople are now notified via SMS text messages when changes to standard inspection availability occurs or new legislation is pending.

#### **Residential Land Sales**

John Potts Stage 7 Residential land is nearly completely sold out with Stage 8 Residential land (17 lots) currently under construction.

#### **Tourism**

Due to the COVID-19 pandemic Tourism activity / promotion fluctuated based on Government restrictions and guidelines. Promotional activities were wound back throughout periods of the latter part of 2020 on advice from State tourism bodies. As travel restrictions ease a focus will be put on increasing tourism promotion.

The Junee Visitor Information Centre (JVIC) was closed from July 2020 to end of October 2020 due to COVID-19 restrictions. The Musuem and JVIC re-opened to the public in November 2020, however due to COVID-19 hours of operation were reduced to three days (Friday — Sunday). Attendances from July to December 2020 were affected as a result of closures and reduced days of operation.

Visitor information brochures and materials continue to be provided at various locations around the Shire including accommodation providers and tourism attractions. Material distribution around the Shire increased as a result of the JVIC being closed.

In September 2020 Council unveiled the completed Bethungra Spiral Viewing Platform. Overlooking the Spiral, the new platforms allows visitors to view the trains as they travel over and through the tunnel. To add an artistic touch, the platform features beautiful rail inspired artwork etched into the side panels.



# **Creating Opportunities for Youth**

In 2021 Council is again spearheading its local employment program towards employing young people with:

- A further three school-based trainees
- Two fulltime trainees
- Support for a Cadet Engineer through Charles Sturt University Bachelor of Engineering

The school-based traineeships have featured strongly over the last five years with over 15 young people having a two-year work placement with the Council. Some have continued working for the Council while others have used that experience to gain employment elsewhere.



In other employment training news the Stronger Country Communities Round Three funded project,

Junee Youth Employment Partnership Program, will start in 2021 which aims to provide students in Years 9 and 10 with practical training and mentorship in hospitality operations, complemented by the completion of a Statement of Attainment in Café Skills.

#### Theme 3: Sustainable

A sustainable community lives in harmony with the built and natural environment, through responsible planning and management practices and using our resources wisely.

This is a wide-ranging theme as it covers not only our responsibility in maintaining and preserving the natural environment, but also to ensure that Council is financially and environmentally sustainable and how we are actively reducing our environmental footprint.

#### Infrastructure

There has been increased funding opportunities by both State and Federal Governments towards renewing local infrastructure. Council has secured over \$3M from these programs for road renewals infrastructure.

# **Greenhouse Footprint**

Council's top five energy consuming assets are: the Sewage Treatment Works (STP), Plant Re-use Water. Junee Junction Recreation and Aquatic Centre (||RAC), Administration Building / Council Chambers and the Junee Library. The



Remelophien Energy faction Plan has been endorsed by council through an independent consultancy in August 2020. The draft plan is due for review in early February 2021.

The Junee Sewage Treatment Plant (STP) has been finalised with improvements to recycled water quality. The STP is now able to support a population of 7,000 people and provide for 30 years growth. The new facility will help to secure Council's water



management plan objectives for effluent reuse and a better environment into the future. The design also incorporates solar panels to offset power loading of the modern treatment process.

Green waste is being mulched instead of being burnt for a lesser impact on the environment. This mulch is then reused to rejuvenate landfill areas and landscaping within the Shire.

The Community Recycle Centre at the Junee Waste Landfill Facility continues to operate well. New segmented areas for drop off points within the facility have been developed so that waste streams are separated ready for recycling. An education program for recyclables was rolled out with information boards placed at two high foot traffic locations, being the Junee Newsagency and Junee IGA.

# **Entrepreneurial Activities**

Council continues to promote employment opportunities resulting from the Inland Rail project.

Council continues to seek major external civil works as part of operations. With over \$IM in enhancement works at the Athenium Theatre over the past I2 months, the facility is available to hire for regional scale events and conferences.

#### Theme 4: Collaborative

"A collaborative community is one where we are socially, physically and culturally engaged and connected. We will have an informed and involved community, build strong relationships and share responsibilities.

The COVID-19 pandemic unfortunately caused many community events and activities planned for 2020 to be cancelled or postponed. As restrictions begin to ease we see the planning of community events recommence.

# **Community**

Two community newsletters were produced and distributed in the second half of 2020 being the Spring 2020 and Summer 2020/21 editions. Feedback received indicates these newsletters are continuing to be useful forms of information for most residents.

Council continues to focus on increasing their social media presence. A steady increase has been seen across all platforms even with the decrease in postings on the tourism focused "You, Me & Junee" channels due to COVID-19 and travel restrictions. Between 1 July and 31 December 2020 Facebook followings have increased 13% on the Junee Shire Council page and 3% on the You, Me & Junee page.

# **Take Charge Forum**

Due to COVID-19 this event did not proceed in 2020. The 2021 Forum has been scheduled for 24 March 2021 in Wagga Wagga.

# **Partnerships**

Council continues to work in partnership with neighbouring councils and government agencies in regional promotion, policy development and service provision. These partnerships include: tourism promotion initiative Canola Trail with Coolamon and Temora Shire Councils, Riverina Regional Library (RRL), Riverina Eastern Regional



Organisation of Councils (REROC), NSW Roads and Maritime Services and NSW Rural Fire Service (RFS).
